

THE NONPROFIT TOOLKIT SUBSCRIPTION AGREEMENT

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS RELATING TO YOUR USE OF THE NONPROFIT TOOLKIT CAREFULLY. By using The Nonprofit Toolkit you agree to the terms and conditions set forth in this Subscription Agreement (this "Agreement"). Unless otherwise specified, we grant you a non-exclusive, non-transferable, limited right to access; use and display The Nonprofit Toolkit and the material provided hereon that you subscribed to, for your noncommercial use, provided that you comply fully with the provisions of this Agreement. You agree not to sell, assign, transfer or sublicense your rights as a registered user of, or subscriber to, The Nonprofit Toolkit. You understand that only you may use your user account and password, and that your subscription to The Nonprofit Toolkit is only valid for your noncommercial use and may not be shared with others. You agree to be financially responsible for all usage of The Nonprofit Toolkit Website as subscribed to by you.

3. The Nonprofit Toolkit: Free and Fee-Based (Premium Edition) Services

4. Charges and Fees for (Premium Edition) Fee-Based Services

Certain portions, components, content and features of The Nonprofit Toolkit Website are only available to those who purchase a subscription to the Website. As a paying subscriber to The Nonprofit Toolkit (Premium Edition) you agree as follows:

A. You agree to maintain and promptly update the Subscription Data to keep it accurate. Without limiting any other provision of this Agreement, if you provide any information that is untrue, inaccurate, or incomplete, or we have reasonable grounds to suspect that such is the case, we reserve the right to suspend or terminate your user account or subscription and refuse any and all current or future use by you of The Nonprofit Toolkit Website.

6. Confidentiality of Information

You are solely responsible for maintaining the confidentiality of your password and user account information.
